The agencies were briefed of the Three Bid Systems adopted and procedures to be adopted for submission of Tenders/Quotations.

During deliberations the following clarifications are made in the tender enquiry the following corrections are made.

1. In para 24 in the technical bid following para is added.

The tenderers/Agencies are required to attach the client/Customer list in the Technical Bid.

2. After Para 24 the following para is added as 24A

The Tenderer/Service providing agencies are required to indicate the Service Tax as applicable on the basic rates quoted and the service tax applicable to be explicitly mentioned.


3. Also in the Commercial Bid to be quoted in the prescribed format of "Annexure A" the following additional categories are added:

In sl.No.5 ETIOS/SWIFT DESIRE

In Sl.No.8 Honda City A/C

The modified "Annexure 'A' accordingly is enclosed, which need to be filled up in the Commercial Bid and to be signed by the tenderer/service providing agency.

4. The other terms and conditions as per the original Tender shall remain the same.
